<u>BRING SHADE</u> structure to crate under! Bring Weights to hold it down. Only 6" stakes allowed.

Trial Site & Information

The show site is outdoors on grass. Ring is 130x80, fenced with open chutes. There is no shade, bring your own! There is limited crating available in covered dugouts for those that do not have a shade tent. Please bring your own crate, clean up supplies, & water bowl for your dog. Dogs must be kept on leash when not in the ring. There is a water hose in the field. A kiddie pool will be set up. Event set up available starting at 9:00am on Friday July 25, 2025. We will start course building at 9:45am, please help.

Trial Site Rules

NO POOPING/PEEING inside the chain length fence – PLEASE take your dog outside of the ballfield, so that we can come back here in the future! Kids play here on a regular basis. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Competition Manager deems the exhibitor to be in violation of this requirement. Competition Manager reserves the right to alter crating arrangements for space, safety or site requirements. Seating is allowed outside of the ring with <u>a minimum of 20ft between seating and ring</u>. Exhibitors are responsible for the conditions in and around their space. No dogs will be permitted to stay overnight at the show site. X-pens allowed.

ANY Unsportsmanlike conduct will result in excusal from the event.

UKI TRIAL INFORMATION YOU MAY FIND HELPFUL....

Measuring

Please ensure you understand the new criteria regarding dogs being measured. UKI Rule Book edition 10

If a dog is under 3 and newly registered, a temporary measure or proof of the dog's height must be done by the dog's 3rd trial. A permanent measure must be obtained by a UKI official measurer between 12-18 months after the dog's first/ temporary measure. Any registered dog that only has a temporary measure, must follow the above rule. If a newly registered dog is over 3, they must obtain a measure by an official UKI measurer by their 3rd trial and this measurement will be permanent.

Course Walk Throughs

It is the competitor's responsibility to be aware of what is happening in the rings and be ready for your course walk throughs. All jump heights will walk at the same time. For example when the Novice Speed Stakes course is up for walking – all heights, including the Select Options will walk.

Gate Sheets- Each class will have call sheets located at the ring. Please check in for your class by ticking your name only when you have walked the course.

Running

It is the competitor's responsibility to know what is going on in the rings. When your jump height is running in your class you must be ready to run.

MOVING UP

Beginners to Novice – Equivalent of 3 clear rounds (12 points, 8 from agility) Novice to Senior – Equivalent of 5 clear rounds (20 points, 12 from agility, 4 from jumping, 4 from games) Senior to Champ – Equivalent of 9 clear rounds (36 points, 12 from agility, 12 from jumping, 12 from games)

UKI does next day move ups!

If you gain enough points on at a trial, you must move up to the next level on the next day or trial. If it is the second day of a trial, please see the trial secretary to fill out a move up form.

Training Rounds – Not for Competition (NFC)

You may opt to make any run you have signed up for a "NFC" training Round for which you may bring in a non-audible toy into the ring. You may not use any food or clickers! You must state NFC prior to entering the ring. The Scribe will write NFC across your scribe ticket, and notify the judge. You will be given the course time to do what you wish. Listen out for the timer to yell "Time!" – You must immediately exit the ring – please stop the finish timing if electronic timing is used.

If you do not notify the judge and scribe ahead of time that you are doing NFC, you will not be able to not turn your run into a training round if you are faulted on course. Repeating any piece of equipment will be deemed training and the judge will ask you to leave the ring immediately if you do this.

Not For Competition Treat Table:

We will be allowing the use of a defined area for treats to be provided to dogs running a NFC run. The area for treat administration will be clearly defined, and only available for rewarding during NFC runs.

Conflicts

If you have a conflict you must put a C beside your name to indicate this. We will make every effort to work you in prior to the class being closed out If you do not pre check in, the class will close without you being able to run. So be sure to check in when you walk through!!!!

Results

It is important that you check your scored result to be sure you agree with your result. If you think there is a problem, you will need to speak to the judge before he or she forgets your run. The judges' decision is final, so if you wait and the judge cannot remember your run, the scribe sheet will stand. Please remember that if the judge disagrees with you once you have stated your case, you must be a good sport and remember that the judge is only human and judging is still subjective. You will win some and you will lose some, but again the judges' decision is final. You can check your scribed run directly at the scoring table during your class.

Once all the heights within a class are finished, the results will be submitted to the show secretary by either downloading from computer scoring, or hand written results sheets, for sorting of level points and reading out for prize givings. The results will then be available for viewing by all competitors.

Marvin Park is adjacent to a long walking trail that goes along the Arkansas River. It is fairly long and will take you to Sand Lake and Franz Lake. There are nicer swimming spots further to the west. My favorite is right under the 291 bridge on the river past Sand Lake. It's a duck lake. I don't recommend swimming your dog there, but you can walk all the way around it. You can quickly get your dog in the river as marked above where the RV's will be parked. Be aware that Salida has a dog leash ordinance, please be respectful.

You also can walk to restaurants going east on Sackett Street.

<u>BRING SHADE WITH YOU!!!</u> There is very limited crating available in the dugouts. Bring a shade structure and weights to hold it down from the wind (tunnel bags work well). NO STAKES over 6" long – irrigation system can be damaged. Expect strong wind at some point.

I will have a kiddie pool in the field for the dogs.

<u>RAIN & WIND</u> – A rain storm with wind may pass over, but summer showers generally go by quickly. Be prepared. The grass is thick enough to maintain traction.
